1. GENERAL PROVISIONS

- 1. This Regulation on the master's thesis (hereinafter referred to as the Regulation) has been developed in accordance with the Law of the Republic of Kazakhstan "On Education", the Law of the Republic of Kazakhstan "On Science", the State Compulsory Standard of Postgraduate Education, approved by the Government of the Republic of Kazakhstan dated August 23, 2012 No. 1080, by orders and regulations of the Ministry of Education and Science of the Republic of Kazakhstan.
- 2. The Regulation defines the mandatory requirements for the structure, content and design of dissertations performed by students of professional master's degree programs at the Kurmangazy Kazakh National Conservatory (hereinafter KNC).
- 3. Master's thesis is a final qualifying scientific work, which is a generalization of the results of an independent study by a master student of one of the topical problems of musicology and art management, which has an internal unity reflecting the course and results of the development of the chosen topic.
- 4. The master's thesis is the result of the research / experimental research work of the master's student, carried out during the entire period of the master's student's training. Master's thesis defense is the final stage of master's preparation.
- 5. The purpose of the master's thesis is to demonstrate the level of scientific / research qualifications of a master's student, the ability to independently conduct scientific research, test the ability to solve specific scientific and practical problems, knowledge of the most general methods and examples of their solution.
- 6. A master's thesis is the basis for awarding a graduate with an academic master's degree in the relevant specialty (scientific and pedagogical direction), and Master of Arts degree (profile direction). It must demonstrate the maturity of the graduate student as a researcher capable of creatively formulating, solving scientific and practical problems.
- 7. Master's theses, before being submitted for defense, must pass pre-defense at the graduating department, a final discussion at the University's Expert Coordination Council and a check in the Science Department for the absence of plagiarism. If evidence of intentional plagiarism is found in the dissertation work, the master's student is not allowed to defend the dissertation and is subject to expulsion from the conservatory in the prescribed manner.
- 8. The vice-rector for scientific and creative activities and international cooperation, scientific supervisors of undergraduates, heads of departments are responsible for the implementation and functioning of this Regulation.

2. REQUIREMENTS FOR THE CONTENT OF THE MASTER DISSERTATION

- 9. The topic of the master's thesis is discussed at a meeting of the graduating department, the Academic Council of the university and is approved by the order of the rector of the conservatory during the first two months of study. At the same time, the scientific supervisor of the undergraduate student is appointed, under whose leadership the research / experimental research work is carried out.
- 10. In the second year, three months before the comprehensive Exam, it is allowed to adjust the topic of the master's dissertation on the basis of a reasoned conclusion of the graduating department.
- 11. The list of topics for master's theses proposed by the graduating department should be updated annually by at least 20%, and provide undergraduates with the opportunity to prepare dissertation research within the framework of scientific topics performed by the graduating department of the university.
- 12. The master's student is given the right to choose the topic of the master's thesis up to the proposal of his own topic with the necessary justification for the expediency of its development.
- 13. Experimental and research work of students of professional master's degree programs of the profile direction of training should:
 - correspond to the main problems of the specialty in which the dissertation is being defended;
 - to be based on modern achievements of musicological science, art management and contain specific practical recommendations, independent solutions to management and other problems;
 - performed using advanced information technologies;
 - contain experimental and research (methodological, practical) sections on the main protected provisions.
- 14. The implementation of research / experimental research work and the preparation of a master's thesis should contribute to the formation of the following key competencies in the graduate:
 - be able to extract, process and use information for professional purposes;
 - possess advanced highly specialized theoretical knowledge and practical skills that serve as the basis for the implementation of scientific research and an original approach to solving professional problems;
 - know the methodology and technique of processing empirical (research) material and be able to use them in scientific and practical activities;
 - be able to critically comprehend and use professional knowledge, including of an interdisciplinary nature;
 - have specialized problem solving skills required for research and / or innovation in order to create new knowledge and methods and integrate knowledge from different fields;

- have communication skills, logically and reasonably express their thoughts, be able to work in a team, be able to take responsibility for their contribution to professional knowledge and professional activities;
- have the ability to original solutions to a specific problem in the area of the chosen specialization;
- be able to manage and transform professional situations that are complex and unpredictable and require new strategic approaches.
- 15. The master's thesis must meet the following requirements:
 - research should be carried out in the work or actual problems in the field of musicology should be solved, art-management;
 - the work should be based on the definition of important scientific problems and their solution;
 - decisions must be scientifically grounded and reliable, have internal unity;
 - the thesis should be written individually.
- 16. The content of a master's thesis is a fundamentally new material, including a description of new factors, phenomena, patterns or a generalization of previously known provisions from other scientific positions or in a new aspect.
- 17. The content of the master's thesis reflects the initial premises of scientific research, its course and the results obtained. The master's thesis has the characteristics inherent in dissertation work in general. The content of the thesis should provide convincing arguments in favor of the chosen concept. The points of view contradicting her should be subjected to a comprehensive analysis and critical assessment. Discussion and polemical material are elements of the dissertation.
- 18. The content of the master's thesis should include the following provisions:
 - substantiation of the relevance, theoretical and practical significance of the research topic;
 - analysis of the state of the issue in the direction of research;
 - setting the goal and specific objectives of the study;
 - determination of the object and subject of research;
 - selection of research methodology and methodology;
 - a description of the stages and process of the research;
 - formulation of conclusions and assessment of the results obtained;
 - determination of the validity, reliability and scientific novelty of the results obtained.
- 19. The results of the master's thesis submitted for defense must be published. The minimum number of published papers is two scientific articles (scientific and pedagogical direction), one article (profile direction). Reports of international and republican conferences can be equated to publications.

3. STRUCTURE, CONTENTS AND RULES OF EXECUTION OF THE MASTER THESIS

20. The volume of a master's thesis should be at least 80 pages for the specialties "Musicology", at least 60 pages for the specialties "Composition", "Traditional performing", "Instrumental performance", "Vocal art", "Conducting", «Artmanagement». Appendices and list of used literature are not included in the specified volume of the master's thesis.

21. The thesis is made in State or Russian language.

Structural elements of the master thesis are:

- 1) title page;
- 2) contents;
- 3) normative references;
- 4) definitions;
- 5) notations and abbreviations;
- 6) introduction;
- 7) main part;
- 8) conclusion;
- 9) the list of the used sources;
- 10) annexes.
- 22. In addition according to contents of the master thesis MA student writes the summary of 0.5 of printed page. (for the profile direction -8 p., for scientific and pedagogical -12 p.). The paper is made out in the Kazakh, Russian and English languages (the summary respectively) and is signed by the author of dissertation.
- 23. The paper of the master thesis has to contain the following data:
- 1) volume and structure of the thesis;
- 2) quantity of illustrations, tables, the used references;
- 3) list of keywords (15-20 words);
- 4) relevance of a research;
- 5) research objective;
- 6) research object;
- 7) research methods;
- 8) the received results, their novelty, the scientific and practical importance;
- 9) data on publications.
- 24. The title page of the thesis is the first page of the thesis and serves as a source of information needed to process and search the document. The title page contains the following information:
 - 1) UDC (can be obtained from the university library);
 - 2) the name of the organization where the thesis is executed;
 - 3) surname, name, middle name of the author of dissertation;
 - 4) name of work;

- 5) the code and the name of specialty (according to the Qualifier of specialties of the higher and postgraduate education);
- 6) required academic degree;
- 7) surname, initials, academic/academic degree and rank of the research supervisor (scientific consultant);
- 8) place of implementation of the thesis and year of end.
- 25. The title page is included in the general numbering of the dissertation pages. The page number is not put on the title page. The title page must contain the personal signature of the applicant, scientific supervisor. The title page is drawn up in accordance with Appendix A.
- 26. The content of the thesis includes an introduction, serial numbers and titles of all sections, subsections, points (if they have names), conclusion, a list of sources used and the title of appendices, indicating the page numbers from which these elements of the thesis begin (Appendix B).
- 27. The structural element "Normative references" contains a list of standards, which are referenced in the text of the thesis. The list includes designations of standards and their names in ascending order of registration numbers of designations.
- 28. The structural element "Definitions, designations and abbreviations" contains the definitions necessary for clarification or establishment are given in one structural element "Definitions, designations and abbreviations".
- 29. The introduction should contain an assessment of the current state of the scientific problem (task) being solved, which has a scientific character, the basis and initial data for the development of the topic, the justification for the need for this research (experimental research) work. The introduction should show the relevance and novelty of the topic, the relationship of this work with other research works, and also the goals, object and subject, research tasks, their place in the implementation of research (experimental research) work in general, should be given, reflects the methodological base, provisions submitted for defense.
- 30.In the main part of the dissertation, data are given that reflect the essence, methodology and main results of the work performed.

- 1) the choice of the direction of a research including justification of the direction of a research, methods of a solution of tasks and their comparative assessment, the description of the selected general technique of carrying out research work;
- 2) process of theoretical and (or) pilot studies, including determination of character and content of theoretical researches, methods of researches;
- 3) generalization and assessment of results of the researches including assessment of completeness of a solution of an objective and the sentence in the further areas of work, assessment of reliability of the received results and their comparison with similar results of domestic and foreign works.

- 31. The conclusion should contain:
 - 1) short outputs by results of a dissertation research;
 - 2) assessment of completeness of solutions of objectives;
 - 3) development of recommendations and basic data on specific use of results;
 - 4) assessment of scientific level of the performed work in comparison with the best achievements in the field.
- 32. The list of the used sources should contain data on the sources used when writing the thesis. The list is made out according to **appendix B**.
- 33.It is recommended to include additional materials which illustrate the thesis content in annexes, but cannot be included in the main part. In annexes can be included:
 - 1) key notes symbols examples;
 - 2) tables, schemes;
 - 3) biographic data of composers, musicians-performance and etc.
 - 4) illustrations (photo) of the auxiliary character.
- 34. Pages of the text of dissertation work, illustrations and tables included in the thesis should correspond to A4 format.
- 35. The thesis should be printed out with use of the computer and printer on one party of a sheet of white paper of A4 format through one interval. A font the Times New Roman, 14. The text of the thesis should be printed with the following sizes: right 10 mm, upper 20 mm, left 30 mm, lower 20 mm. It is allowed to use computer opportunities of emphasis of attention on certain terms, formulas, theorems, applying fonts of the different headset.
- 36. The surname, name of the organization, title of works and other proper names bring in theses in the original language. It is allowed to transliterate proper names and to provide names in translation into the thesis language with adding (at the first mentioning) the original name.
- 37. Names of structural elements of the thesis "Contents", "Normative references", "Definitions", "Notations and Abbreviations", "Introduction", "Conclusion", "The list of the used sources" serve as headings of structural elements of the thesis.
- 38. The main part of the thesis should be divided into sections, divisions and paragraphs. Paragraphs, if necessary, can be divided into subparagraphs. At division of the text of the thesis into paragraphs and subparagraphs it is necessary that each paragraph contained the finished information. Sections, divisions should have headings. Paragraphs, as a rule, have no heading. Headings should reflect accurately and briefly contents of sections, divisions. Headings of sections, divisions and paragraphs should be printed from a paragraph indent from uppercase letter without full stop at the end, without emphasizing. If the heading consists of two sentences, then they are divided by full stop.

- 39. Pages of the thesis should be numbered in the Arab digits, observing through numbering in all text of the thesis. The page number is put down in the center of the lower part of a leaf without full stop.
- 40. The front page is included in the total pagination. The page number on the front page is not put down.
- 41. The illustrations and tables located on separate pages are included into the total pagination of the thesis. Illustrations, tables on the sheet A3 are considered as one page.
- 42. Sections of the thesis should have the sequence numbers within the whole work noted by the Arab digits without full stop and written from a paragraph indent. Divisions should have numbering within each section. Number of the division consists of numbers of the section and the division divided by full stop. At the end of number of the division full stop is not put. Sections, as well as divisions, can consist of one or several points.
- 43. If the thesis has no divisions, then numbering of paragraphs in it should be within each section, and number of paragraphs should consist of numbers of the section and of the paragraph divided by full stop. At the end of number of paragraph full stop is not put.

Example

- 1 Erkegali Rakhmadiyev: traits of creativity
- 1.1 Creative activity of the composer Erkegali Rakhmadiyev
- 1. Periods of creativity
- 2 Symphonic works of Erkegali by Rakhmadiyev
- 2.1 Symphonic poem "Tolgau"
- 2.2 Symphonic kuy "Dayrabay"

If the thesis has divisions, then numbering of paragraphs must be within the division and number of paragraph must consist of numbers of the section, of the division and of the paragraph divided by full stops, **for example**:

- 3 E. Rakhmadiyev's opera "Kamar Sulu"
- 3.1 To the problem of genre
- 3.1.1 The origins of the genre
- 44. If the section consists of one division, then the division is not numbered. If the division consists of one paragraph, then paragraph is not numbered. If the text is divided only into paragraph, then they are numbered by serial numbers within the whole dissertation work.
- 45. Paragraphs, if necessary, can be broken into subparagraphs which have to have serial numbering within each paragraph, for example: 4.2.1.1, 4.2.1.2, etc.

46. Before each citation it is necessary to put a hyphen or, in need of the reference in the text of the document for one of citations, a lowercase letter (behind an exception ë, 3, й, 0, ч, ь, ы, ъ) after which the bracket is put.

For further specification of citations it is necessary to use the Arab digits after which bracket is put, and record is made from a paragraph indent, as shown in an example.

- 47. Each structural element of the thesis should start from a new sheet (page).
- 48. The numbering of the pages of the thesis and the appendices included in the thesis must be end-to-end.
- 49. **Illustrations** (drawings, graphs, maps, diagrams, computer printouts, diagrams, photographs) should be placed in the thesis immediately after the text in which they are mentioned for the first time or on the next page. Illustrations can be computer-generated, including color. All illustrations should be referenced in the dissertation.
- 50. Illustrations, with the exception of illustrations in the annexes, should be numbered with Arabic numerals continuously. If there is only one picture, then it is designated "Picture 1", The word "Picture" and its name are placed in the middle of the line, through a dash, on top.
- 51. Tables are used for better demonstration and convenience of indexes comparison. The name of the table has to reflect its contents, to be exact and short and is located over the table at the left, without paragraph indention in one line with its number with dash. At syllabification of a part of the table on other page the lower horizontal line on the first page is not closed, the word "Continuation" should be written over the other parts at the left, specifying the number of table, for example: "Continuation of table 1".
- 52. The table should be placed in the thesis immediately after the text in which it is mentioned for the first time, or on the next page. All tables should be referenced in the dissertation. When referring, you should write "Table" with its number. Tables, with the exception of annex tables, should be numbered with Arabic numerals sequentially. It is allowed to number tables within a section. In this case, the table number consists of the section number and the sequence number of the table, separated by a dot. The tables of each annex are numbered separately in Arabic numerals with the addition of an application designation before the number.
 - 53. **Notes** should be capitalized from a paragraph in a row and not underlined. Notes are given in the thesis, if explanations or reference data are needed to the

- content of the text, tables or graphic material. Notes should be placed immediately after text, graphic material or in the table to which these notes refer. If there is only one note, then a dash is placed after the word "Note" and the note is printed with a capital letter. One note is not numbered. Several notes are numbered sequentially in Arabic numerals without a period. A note to the table is placed at the end of the table above the line indicating the end of the table.
- 54. **References** to the sources used should be given in square brackets. Reference should be made to the document as a whole or to its sections and appendices. References to subsections, paragraphs, tables and illustrations are not allowed. When referring to standards and specifications, only their designation is indicated, while it is allowed not to indicate the year of their approval, provided that the standard is fully described in the list of sources used.
- 55. Designations and abbreviations are arranged in a column and given in the order of their bringing in the text with the necessary decoding and explanations. It is allowed to give definitions, designations and abbreviations in one structural element "Definitions, designations and abbreviations".
- 56. **The list of sources used contains** information about the sources, arranged in the order of appearance of references to sources in the text of the thesis, and numbered in Arabic numerals with a period. You should print without indentation.
- 57. **Appendices** are drawn up as a continuation of the dissertation on its subsequent pages or issued as a separate document. The appendix should have a sequential pagination in common with the rest of the document. All appendices should be referenced in the thesis text. Appendices are arranged in the order of references to them in the text of the thesis. Each appendix should start on a new page with the word "APPENDIX", its designation and degree indicated at the top in the middle of the line. The application must have a title that is written symmetrically relative to the capitalized text on a separate line. Applications are designated in capital letters of the Russian alphabet, starting with the letter A, with the exception of the letters E, Z, Y, O, H, L, Y, b. The word "APPENDIX" is followed by a letter denoting its sequence. In the case of full use of the Russian alphabet, the use of the Latin alphabet is allowed, except for the letters I, O, and then the Arabic numerals.

4. REPRESENTATION AND PROCEDURE OF PROTECTION OF THE MASTER THESIS.

58. The master thesis issued according to the established requirements is submitted on the releasing department not later than three months before estimated date of protection for passing of the procedure of preliminary protection and receiving a response of the research supervisor. If according to the master thesis the scientific consultant for an allied industry of sciences was in addition

- appointed, then responses of the research supervisor and scientific consultant prepare separately, independently of each other.
- 59. Responses of the research supervisor and scientific consultant (if any) are given to MA student within 10 (ten) days from the date of passing of the procedure of preliminary protection with the indication of the reasoned conclusion "is allowed to protection" or "is not allowed to protection".
- 60. After successfully passing the pre-defense procedure, in the presence of positive feedback from the scientific supervisor and the scientific (creative) consultant (if any) with the conclusion "admitted to defense" and the conclusion on checking the dissertation for the absence of plagiarism in accordance with the procedure established by the KNC, the candidate submits a dissertation on expertise.
- 61. The procedure for the examination of the thesis, preparation of the relevant documents and admission of the candidate for the defense is carried out by the Science Department in the period between the comprehensive examination and the defense of the thesis and should not exceed one month.
- 62. For the examination of the dissertation during the training of the master's student, the Expert Coordination Council is formed, the composition of which is approved by the Order of the Rector.
- 63. One copy of the thesis, accepted for defense, and two copies of the abstract are submitted by the master student to the KNC library, no later than 15 days before the defense and are stored there, as a manuscript until the defense of the thesis. After successful defense, the dissertation and one copy of the abstract are transferred to the archive of the university. Otherwise, the dissertation and two copies of the abstract are returned to the master student.
- 64. An official reviewer is appointed for a master's thesis, whose qualification (academic or academic degree) corresponds to the profile of the work being defended. The official reviewer does not have to be teacher of KNC.
- 65. The candidacies of official reviewers are approved by the order of the rector no later than 1.5 (one and a half) months before the defense on the basis of the presentation of the head of the graduating department, including the justification for the appointment of an official opponent, personal data indicating the place of work, position held, academic degree, scientist titles and a list of the main publications on the profile of the reviewed master's thesis (at least 3 works) and the written consent of the prospective reviewers.
- 66. The official reviewer, on the basis of the study of the master's thesis and published works on the topic of the dissertation, within 10 (ten) days from the date of the publication of the order on the appointment of official opponents, prepares a review in writing, in which he gives a comprehensive description of the dissertation, objectively evaluates the relevance of the chosen topic, provisions, conclusions and recommendations formulated in the dissertation, their novelty. In the summarizing part of the review of the official opponent, a reasoned conclusion must be given indicating the grade ("excellent", "good", "satisfactory", "unsatisfactory") and the possibility of awarding an academic master's degree in the relevant specialty.

- 67. A copy of the official opponent's review is given to the master student no later than 10 days before the defense of the thesis.
- 68. MA student is allowed to defence after successful passing complex examination in the presence:
 - 1) positive reviews of the research supervisor and scientific consultant (original);
 - 2) not less than one publication (the profile direction) and not less than two publications (the scientific and pedagogical direction) on a thesis in scientific publications;
 - 3) written conclusion of Expert coordination council about the recommendation to public defence of a thesis;
 - 4) review of the official reviewer in which comprehensive characteristic of the thesis and the reasoned conclusion with the indication of assessment ("excellent", "good", "satisfactory", "unsatisfactorily") and possibilities of award of the academic degree of the master on the corresponding specialty is given. In case the research supervisor (the scientific consultant) or Expert coordination council draw the negative conclusion "it is not allowed to defence" or "it is not recommended to defence" MA student cannot defend the master dissertation.
- 69. The admission of MA student to defence of a thesis is made out by the order of the head of higher education institution not later than two weeks before defence of a thesis.
- 70. Defence of the master thesis is carried out at a meeting of SCC, the magistracy created on this specialty.
- 71. The rector of KNC presents candidacies for position of Chairmen of SCC to MCS of RK until November 1
- 72. The chairman of SCC on specialties of magistracy should have an academic degree of the doctor or candidate of science, or the academic degree of the doctor of PhD / on a profile of the let-out specialists corresponding to a profile. The chairman SCC should not be the employee of the organization in which this statecertifying commission is being established.
- 73. The Chairman of SCC is appointed by the order of authorized body for calendar year no later than December 20 of the current academic year.
- 74. Persons with an academic degree of the doctor and candidate of science, the academic degree of the doctor of PhD / on a profile, corresponding to a profile of the let-out specialists are a part of SCC as its members;
- 75. The quantitative and qualitative structure of SCC is defined by higher education institution or the scientific organization independently and is approved by the order of the rector no later than December 31 and acts within calendar year.
- 76. In addition to SCC the Dean of Faculty and the author of dissertation submit the following documents:

- 1) reference from the dean of faculty about execution by MA student of the individual curriculum, the estimates received by it on all disciplines, their volume which are handed over to term papers and types the practices.
 - 2) response of the research supervisor (scientific consultant) of MA student;
 - 3) conclusion of Expert coordination council;
 - 4) review of the official reviewer of the master thesis;
 - 5) certificate of passing the check for borrowing.
 - The SCC may also submit other materials characterizing the scientific and practical value of the completed master's thesis, unofficial reviews, written opinions from organizations carrying out practical activities in the profile of the master's thesis, certificates or acts of implementing the results of scientific research.
- 77. A meeting of the SCC for the defense of master's theses is considered competent if attended by at least 2/3 of its members.
- 78. The official reviewer and scientific adviser are obliged to be present at the defense of the dissertation. As an exception, it is allowed to defend a master's thesis in the absence, for a good reason, of an official reviewer who gave a positive review on the dissertation. In this case, at the meeting of the SCC the review of the absent reviewer is fully announced.
- 79. The procedure for the defense of a dissertation work is determined independently by the university. Forms of the defense of dissertations online (ZOOM platform), offline (depending on the epidemiological situation in the Republic of Kazakhstan)
- 80. Public defense of the dissertation should be in the nature of a scientific discussion and take place in an atmosphere of high exactingness, integrity and adherence to scientific ethics, while the novelty, validity of the results, conclusions and recommendations of a scientific and practical nature contained in the dissertation should be thoroughly analyzed.
- 81. The decision on the results of the defense of the master's thesis is made by the SCC at a closed meeting by open vote by a simple majority of votes of the members of the SCC who participated in the meeting and is drawn up in the minutes of the established form.
- 82. The protocol is signed by the chairman and members of the SCC who participated in the meeting.
- 83. The dissertation, on the basis of the results of defense of which the SCC made a negative decision, may be submitted for re-defense in a revised form not earlier than one year after the negative decision was made. In case of repeated defense, the entire procedure for admission to defense is repeated, the members of the Expert Coordination Council and the official reviewer must be completely replaced.
- 84. The results of the defense of dissertations are announced on the day they are held.

- 85. A master's student who publicly defended his master's thesis is awarded an academic master's degree in the relevant specialty on the basis of the minutes of the SCC meeting drawn up in the prescribed form.
- 86. Upon completion of the final attestation of undergraduates, the Chairman of the SCC draws up a report and submits it to the rector of the KNC within two weeks.
